



Fee income per equity partner (£'000)






Number of fee earners per equity partner






Total salaries, including notional salaries, as a % of fee income (%)






Non salary overheads as a % of fee income (%)






Number of secretaries per fee earner






Profit per equity partner (£'000)






Profit as a % of total income (%)






Profit per equity partner after notional salary and notional interest (£'000)
