# The fast track procedure

- Competition Appeal Tribunal Rules 2015, rule 58
  - trial within 6 months or as soon as practicable
  - costs to be capped
  - test for fast track procedure:
    - one of parties is individual or SME
    - trial time estimate of 3 days or less
    - "complexity and novelty of the issues involved"
    - number of witnesses
    - scale and nature of the documentary evidence
    - whether disclosure sought and, if so, extent thereof
    - nature of remedy sought/ amount of damages



## The fast track procedure

- Guide to Proceedings 2015, §§ 5.139-5.149
  - FTP can be used in damages actions, but not collective proceedings
  - Application for FTP to be made with claim form and costs budget to be provided
  - Explains matters set out in rule 58(3)
  - Given the complex nature of competition claims only FTP in "clear-cut cases", e.g. injunctions
  - Interim injunctions granted without or with capped undertaking as to damages
  - Close case management and specific disclosure only



# The Socrates litigation

- Timetable to trial:
  - 5 April 16 claim form and application for FTP served on Law Soc
  - 12 May 16 Law Soc defence
  - 16 May 16 CMC; FTP designation; split trial; amended pleadings; limited disclosure; witness statements and limited expert evidence; 3-4 day hearing in first week of Nov
  - 21 Jun 16 second CMC; further specific disclosure; costs capping; PTR listed



# The Socrates litigation

- 22 Jul 16 disclosure; witness statements and further information
- 29 Sep 16 expert reports exchanged
- 5 Oct 16 application to adduce further expert evidence refused factual analysis instead
- 14 Oct 16 PTR; trial timetable; bundles; skeleton arguments
- 8-11 Nov 16 hearing
- 26 May 17 Judgment on liability

# Walter Merricks CBE v Mastercard – key funding features

#### Interesting features / issues

- The funding agreement
  - Funder's potential return
  - Funder's reward stated as only payable out of undistributed damages question whether this qualified within the references in the legislation to
    - <u>costs or expenses</u>
    - incurred by the representative

in connection with the proceedings (see section 47C(6) CA 1998 and rule 93(4) of CAT Rules 2015)

- Accessibility of agreement (confidentiality; style)

# Walter Merricks CBE v Mastercard – CAT's decision on funding

### Key points from CAT's decision

- Funder's return was a "cost or expense" of the litigation for the purposes of collective proceedings costs rules
  - Funding costs therefore potentially recoverable from undistributed damages
  - NB changes required to agreement to ensure cost or expense was incurred by the Applicant
- Adverse cover provided for in agreement was sufficient in the context of the CPO hearing
- Concerns re potential conflict of interest rejected
